

ADDITIONAL TERMS AND CONDITIONS

The purchaser agrees to provide the following at their expense:

1. Dressing area that is convenient to the performance area with convenient bathroom facilities.
2. A healthy meal for two people and two bottles of water.
Due to the complexity of artist's schedules, we have listed the meal options in order of preference to the artist. Please check one before returning the signed contract and rider so that preparations can be made.
 - a. _____ Add an additional \$40 to the show price. *(Please present directly to the artist)*
 - b. _____ Arrange for a \$50 meal allowance charge back to room to be used for room service or meal purchased at hotel restaurant.
 - c. _____ Provide a meal after the performance. *(Please note that options a. and b. are preferred when a performance is going to be ending after 10:30pm.)*****Colleges & Universities** – Meals in the dining hall will only be accepted if it's available within 30 minutes of the scheduled beginning or ending time of the performance. Please have an event coordinator accompany the ARTIST if the performance venue and the dining hall are not located in the same location.
3. Artist reserves the right to retain 100% of merchandise sale proceeds.
4. Sound, Light, Electricity & Staging requirements:
 - Music Video Mania provides all or it's own sound
 - Music Video Mania is a self-contained show that supplies it's own studio style lighting. Music Video Mania will work fine with standard room lighting
 - Music Video Mania requires at least two electrical outlets on a designated 20 AMP circuit. Music Video Mania can work with just about any electric provided. However, please not if there is a big draw on the same circuit we are operating on, the quality of the videos will be effected.
 - Music Video Mania requires a performance area that is at least an area of 10x10 feet, however, 20x20 is preferred. An elevated stage is not needed, however, would be used if supplied.
5. Music Video Mania is adaptable to any location; theatre, multi-purpose room, lounge or hallway. Music Video Mania can also be performed in outside conditions if weather permits.
6. Music Video Mania requires at least 4 eight-foot banquet style tables or 6 six-foot banquet style tables. These tables are used to set-up equipment as well as set-up the costume collection.
7. Music Video Mania may require assistance of a few helpers to assist with load-in and load-out. Please advise our office of the type of load-in, and any obstacles we may encounter (i.e. steps, far distance from loading docks, etc.)
8. A television monitor or two, depending on the location would help enhance the show. Monitors would be used to patch in the recorded feed so that the audience can see the finished product. This is NOT NEEDED for the contract, just an added extra that can help. Music Video Mania can use an existing TV in the area provided as long as we can access the video inputs.
9. **Artist Ground Transportation [[Directions Link]].**
It is the responsibility of the purchaser to assure that adequate transportation is provided to/from the airport/hotel/venue. If the venue *is not* within 75 miles of an airport served by a major carrier, please provide \$60 for a transportation buyout (to cover car rental and gas). If venue *is* within 75 miles, but purchaser cannot provide transportation, please provide \$60 for a transportation buyout.

10. Hotel: **[[CO-OP 1]], [[Co-OP 2]].**
 - In the event the artist is responsible for lodging, please provide a list of acceptable lodging establishments on a separate sheet & please DO NOT fill out the hotel information below.
 - If the purchaser has already agreed to provide a hotel, please do not cross off the hotel and send it back for initials – CONTACT NEON FIRST.
 - For artist's safety, we prefer rooms that do not have direct access to outdoor parking areas (i.e. motels). When possible please provide rooms at an established hotel chain (Comfort Inn, Holiday Inn, Best Western etc.)
 - ARTIST reserves the right to ask for a hotel buyout at any point up 48 hours before the event.
 - If the artist(s) is to stay in a guest room, the room must have a telephone, television, and private bathroom.
 - Please be sure to guarantee the rooms for late arrival and confirm that the hotel has all the direct billing details necessary.
