

ADDITIONAL TERMS AND CONDITIONS

The purchaser agrees to provide the following at their expense:

1. Clean, well-lit, air conditioned/heated dressing area for six (6) people with proper security to guarantee the safety of the Artist and Artist's property that is convenient to the performance area with convenient bathroom facilities. The dressing area shall contain a minimum of eight (8) chairs, four (4) AC outlets, one (1) full length mirror, six (6) large clean towels, one (1) 9 Volt battery, and two (2) large trash bins with garbage liners.

Suggestions for furnishing the dressing area: one (1) case of bottled water, 4-pack of Diet Energy Drink, fresh fruit assortment, assorted soda's, potato chips, sandwich platter, sandwich condiments, plastic knives, spoons, forks and cups.

2. Please have bottled water available for performance. Please have at least five (5) bottles on ice and five (5) at room temperature if possible.
3. Artist prefers a cash buyout for six (6) people of TEN US DOLLARS (\$10.00) per person in local currency at current exchange rate payable to Artist's tour manager upon demand, if above meal requirements are unavailable or unacceptable, then hot nutritious meals for six (6) people must be provided. ABSOLUTELY NO FAST FOOD.

Due to the complexity of artist's schedules, we have listed the meal options in order of preference to the artist. Please check one before returning the signed contract and rider so that preparations can be made.

- a. ____ Add an additional \$60 to the show price. *(Please present directly to the artist)*
- b. ____ Arrange for a \$150 meal allowance charge back to room to be used for room service or meal purchased at hotel restaurant.
- c. ____ Provide a meal after the performance. *(Please note that options a. and b. are preferred when a performance is going to be ending after 10:30pm.)*

****Colleges & Universities** – Meals in the dining hall will only be accepted if it's available within 30 minutes of the scheduled beginning or ending time of the performance. Please have an event coordinator accompany the ARTIST if the performance venue and the dining hall are not located in the same location.

4. Artist reserves the right to retain 100% of merchandise sale proceeds. The band will sell merchandise, including T-shirts, recorded material, stickers, etc. Please provide at least one 8'x4' area in a well lit high traffic area of the venue for artist merchandise booth. It is extremely helpful if you arrange for the area to be available and set in place before artist arrives.
5. Sound will be provided by [[CO-OP]].
6. If sound is to be provided by Purchaser, the following is required (technical questions, please contact Daniel Oliver, 210-834-3660, Support@nothingmore.net):
 - a. At least one (1) sound technician provided by the purchaser/promoter/venue should be available at all times to work with the band. This includes from the time the band is scheduled to load-in until the event is completely finished. More than one (1) sound technician is highly recommended.
 - b. Minimum PA requirements include a 24-channel mixing console, mics for all amplifiers and to accommodate a 5-piece drum kit. A direct out XLR for bass, two (2) instrument mics for guitars and four (4) vocal microphones should be provided with a minimum of three (3) boom stands and at least three (3) quality floor wedge monitors.
 - c. Stage Plot:
Stage Right: 1 Boom stand with vocal mic
Power reaching to the front of the stage to plug in pedal board
Power in back of the stage to plug in bass rig
On stage right will be bass rig and computer interface

Center Stage: 1 Straight stand with vocal mic
1 drum microphone to mic up kick of auxiliary set
Center stage will be lead singer with his auxiliary drum set

Stage Left: 1 Boom stand with vocal mic
Power reaching to the front of the stage to plug in pedal board
Power in back of stage to plug in guitar amp
Stage Left will be guitar player

Center Rear: Everything necessary to mic up a 5-piece drum set

Stage size: Minimum of 8 feet required from the front of the drum riser to the front of the stage.
7. The band will require adequate parking for a 40ft RV and trailer for the duration of the event and as well as overnight if possible. Sufficient parking will be provided and venue agrees to validate if necessary. Band requires external power for the RV (110 AC Plug).
8. Six (6) day passes to the college gym

9. **Artist Ground Transportation**

- Artist will provide ground transportation
- Purchaser will provide ground transportation for the artist (to & from the airport & hotel)
- Purchaser will provide \$60 transportation buyout to be paid to the artist

10. **Hotel: [[CO-OP 1]], [[Co-OP 2]] (3 Double Rooms).**

- If a hotel cannot be provided, please add \$375 to the contracted price. (If full payment is made to Neon Entertainment, please present hotel buyout compensation directly to artist.
_____ Please initial here if you will be taking the hotel buyout.
- If the purchaser has already agreed to provide a hotel, please do not cross off the hotel fill-in below and send it back for initials – CONTACT NEON FIRST.
- For artist's safety, we prefer rooms that do not have direct access to outdoor parking areas (i.e. motels). When possible please provide rooms at an established hotel chain (i.e. - Comfort Inn, Holiday Inn, Best Western, etc.)
- ARTIST reserves the right to ask for a hotel buyout at any point up 48 hours before the event.
- If the artist(s) is to stay in a guest room, the room must have a telephone, television, and private bathroom.
- Please be sure to guarantee the rooms for late arrival and confirm that the hotel has all the direct billing details necessary.
