

ADDITIONAL TERMS AND CONDITIONS

The purchaser agrees to provide the following at their expense:

1. Dressing area that is convenient to the performance area and to bathroom facilities
2. A healthy meal for three people and one case of bottled water. (Please no fast food or pizza)
 - As well as, an assortment of fresh whole fruit, one box of granola bars, one large bag of Starburst or Skittles, one twelve pack of Gatorade or Powerade, hot tea and coffee and all necessary accompaniments (honey, cups, etc.)

Due to the complexity of artist's schedules, we have listed the meal options in order of preference to the artist. Please check one before returning the signed contract and rider so that preparations can be made.

 - a. ___ Add an additional \$60 to the show price. *(Please present directly to the artist)*
 - b. ___ Arrange for a \$75 meal allowance charge back to room to be used for room service or meal purchased at hotel restaurant.
 - c. ___ Provide a meal after the performance. *(Please note that options a. and b. are preferred when a performance is going to be ending after 10:30pm.)*

****Colleges & Universities** – Meals in the dining hall will only be accepted if it's available within 30 minutes of the scheduled beginning or ending time of the performance. Please have an event coordinator accompany the ARTIST if the performance venue and the dining hall are not located in the same location.

3. Artist reserves the right to retain 100% of merchandise sale proceeds.
4. Sound will be provided by [[CO-OP]]. If purchaser is responsible for sound, ALL sound requirements on the following two pages (Stepanian's technical rider) must be provided or a sound buyout must be taken.
5. Five (5) Nine-volt batteries & six (6) AA-batteries
6. Allow artist access to venue for load-in and set-up atleast two (2) hours prior to opening doors.
7. Provide parking for one (1) 15-passenger van or two (2) SUV's (as per advance) close to loading area. Additionally, one (1) guest-parking pass for an extra band vehicle would be greatly appreciated.
8. Three (3) loaders to assist with load-in and load-out of Artist's equipment
9. Sixty minutes for a sound check. The sound check should not be scheduled to occur during or run into forty-five minute period prior to the scheduled on stage time. As well, the venue should preferably be absent of a large amount of people during the sound check.
10. **Artist Ground Transportation**
Choose One:
 - ___ Artist will provide ground transportation
 - ___ Purchaser will provide ground transportation for the artist (to & from the airport & hotel)
 - ___ Purchaser will provide \$60 transportation buyout to be paid to the artist

11. Hotel: [[CO-OP 1]], [[Co-OP 2]] (2 Double Rooms).
 - If a hotel cannot be provided, please add \$250 to the contracted price. (If full payment is made to Neon Entertainment, please present hotel buyout compensation directly to artist.
___ Please initial here if you will be taking the hotel buyout.
 - If the purchaser has already agreed to provide a hotel, please do not cross off the hotel fill-in below and send it back for initials – CONTACT NEON FIRST.
 - For artist's safety, we prefer rooms that do not have direct access to outdoor parking areas (i.e. motels). When possible please provide rooms at an established hotel chain (i.e. - Comfort Inn, Holiday Inn, Best Western, etc.)
 - ARTIST reserves the right to ask for a hotel buyout at any point up 48 hours before the event.
 - If the artist(s) is to stay in a guest room, the room must have a telephone, television, and private bathroom.
 - Please be sure to guarantee the rooms for late arrival and confirm that the hotel has all the direct billing details necessary.

STEPANIAN TECHNICAL RIDER

Power Requirements

Adequate power must be provided by the venue to effectively run sound, lights, and band gear. This shall include three (3) separate front of stage outlets for effect-board power and three (3) separate rear of stage outlets for amplifiers

Stage Requirements

A stage at least 16' X 24' and 2' to 4' in height must be provided. The stage area is for performance only. If the P.A. must be elevated, stage wings must be added.

Lighting Requirements

Purchaser to provide adequate stage lighting with a 4-color wash.

Monitor Mixes

Three (3) monitor mixes required (all with 31 band EQ's if possible)

One (1) VOX 1 – Mix delivered via XLR or 1/4" Phono Plug for Wireless In-Ear Monitor System (monitor provided)

One (1) VOX 2 – Mix delivered via XLR or 1/4" Phono Plug for Wireless In-Ear Monitor System (monitor provided)

One (1) VOX 3 – Mix delivered via XLR or 1/4" Phono Plug for Wireless In-Ear Monitor System (monitor provided)

(Alternatively, 3 independent monitor mixes may be supplied via floor monitors, though use of in-ears is preferred)

Stands, Cables, Mics, & DI's

Three (3) tripod booms

Three (3) vocal mics (Stepanian will provide)

Two (2) short booms

Two (2) amp mics

Twelve (12) working mic cables

Miscellaneous

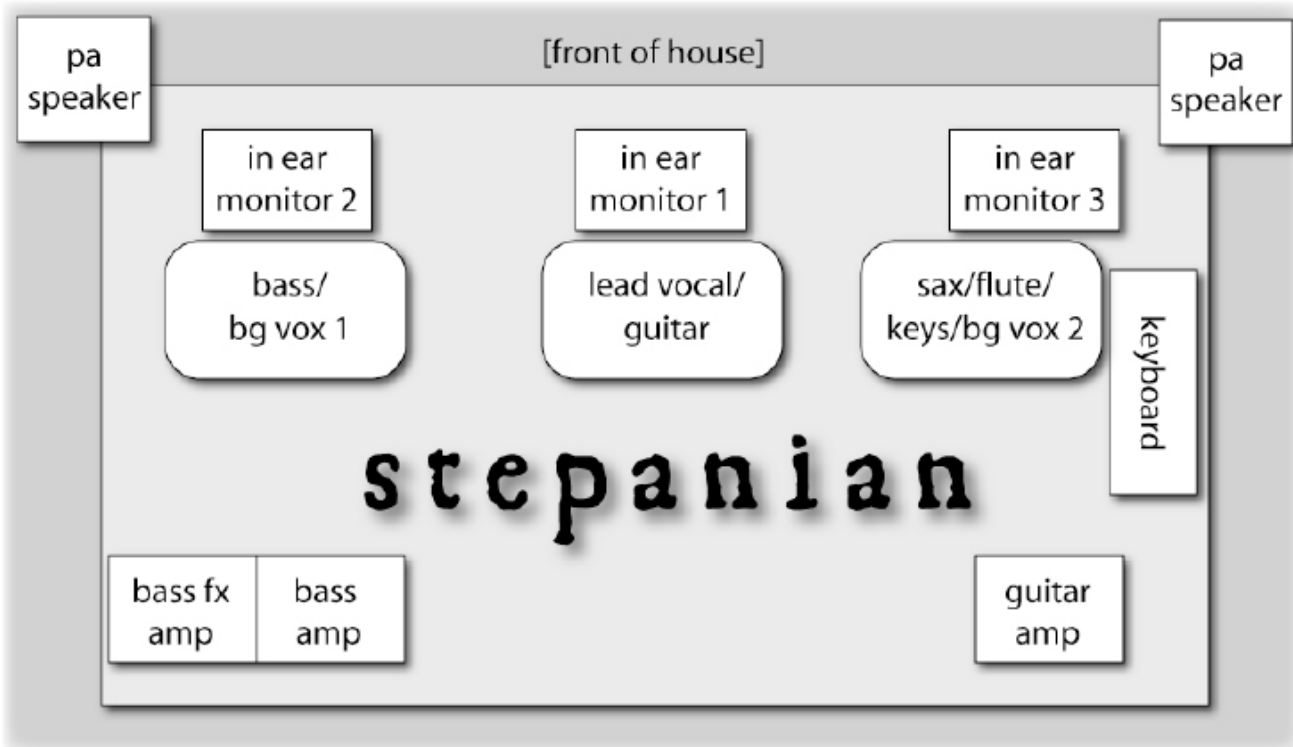
- The P.A. system must be wired in stereo and must have dual 31-band graphic EQs at FOH.
- The P.A. system must have a three or four way FOH speaker configuration of subs, mids, and highs capable of maintaining clean and clear sound throughout the entire venue.
- The FOH console must have no less than 24 working channels and 4 subgroups. The main snake must have no less than 24 working channels as well as a 24 channel split to the monitor desk.
- The monitor desk must have no less than 24 working channels.

All changes to this rider and attached contract must be in writing, and initialed by both artist and purchaser. Unless waived, all terms and provisions herein shall be agreed to and provided by purchaser.
